**WHEREAS**, the Securities Division of the Office of the Attorney General of the State of South Carolina has been authorized and directed by the Securities Commissioner of South Carolina (the “Securities Commissioner”) to administer provisions of S.C. Code Ann. § 35-1-101, et seq., the South Carolina Uniform Securities Act of 2005 (the “Act”); and

**WHEREAS**, pursuant to S.C. Code Ann. § 35-1-412(f), the Securities Commissioner may summarily suspend a Respondent’s registration before the final determination of an administrative proceeding;

**NOW THEREFORE**, upon due consideration of the subject matter contained in a related administrative proceeding under the Act having the same file number, 13030, and having reason to believe that Respondents violated certain provisions of the Act and the Rules promulgated thereunder;

**IT IS HEREBY ORDERED** that, pursuant to S.C. Code Ann. § 35-1-412(f), the investment adviser and investment adviser representative registrations of Respondents have been

and are **SUMMARILY SUSPENDED**. This suspension will remain in effect pending resolution of the related proceeding.

**NOTICE AND OPPORTUNITY FOR A HEARING**

Pursuant to S.C. Code Ann. § 35-1-412(f), Respondents are hereby given notice that they may request a hearing on the summary suspension by giving written notice to Thresechia Navarro, Post Office Box 11549, Rembert C. Dennis Building, Columbia, South Carolina 29211-1549. In the event such a hearing is requested, within fifteen (15) business days after the receipt of a written request the matter will be scheduled for a hearing. If a hearing is not requested and none is ordered by the Securities Commissioner within 30 days after the date of service of the order, the order becomes final by operation of law and will remain in effect until it is modified or vacated in accordance with the Act.


